Remarks:

- Shipments up to 20kg are calculated in 0.5kg increments, weight in decimal kg will be rounded up to the nearest 0.5kg; Shipments over 20kg are calculated in 1kg increments, weight in decimal kg will be rounded up to the nearest kg.
- Below shipments exported to Mainland China/Hong Kong/Macau are required to use Shipment Protection Plus Service(SPP):
 - 1) Shipment declared value between NTD 20,001 to NTD 200,000, and the weight is equal to or below 10kg, or
 - 2) Shipment declared value above NTD 200,000, and the declared value per kg is between NTD 20,001 to NTD 40,000 shall be purchased.
- The above rates consist of 5% Business Tax, which do not include fuel surcharge and other special handling fees.
- The chargeable weight (kg) of a shipment is determined by the actual gross weight or the volumetric weight (L x W x H (cm) ÷ 6000), whichever is greater.
